

Foothills Board Meeting July 12th Board Meeting 6:30 pm Zoom

Finance (See attached Finance Report):

Bank Balance \$16,771.39

General Fund \$7,153.67 General Fund Activity: The fund had miscellaneous holdover income from the Melissa Creswick clinic as well as minor (hospitality) expenses related to that event. There was one (\$200) scholarship reimbursement. Additional expenses were a new post office box (\$42) and the annual web hosting fee (\$168). A \$500 deposit has been paid to Starr Vaughn Equestrian Center for the October Foothills Classic and NDPC Championship. These checks have not cleared and therefore are not reflected in the above balance. The Board will need to determine how to expense Fall Classic/NDPC costs between our two funds as we incur additional expenditures in the coming weeks.

Junior Fund \$9,617.72 Junior Fund Activity: There was no income reported from the junior gift shop for the past month. Scholarship reimbursements totaled \$175.00. The amount above does not include payment to CDS for insurance for the Equine Wellness clinic as that check is outstanding.

A member did bring up concern about funding Fall Classic/NDPC with any junior funds as those are designated for scholarships. As the Fall Classic/NDPC is a fundraiser if no funds are used then there would also be no profit sharing. Since this event is still in process and all contracts have not yet been written or signed this discussion was closed until further into the planning process.

A draft of Fall Classic/NDPC expenses was presented. This spreadsheet did not reflect expense sharing with NDPC nor sponsorships that have been received

Gift Shop

The gift shop continues to be a point of frustration for those juniors that are volunteering. Although this has been a successful fundraiser during Covid. Misty made a motion to

halt any further events until the board can decided how to proceed. Ana second the motion. Bonnie agreed. Some ideas that were presented:
